

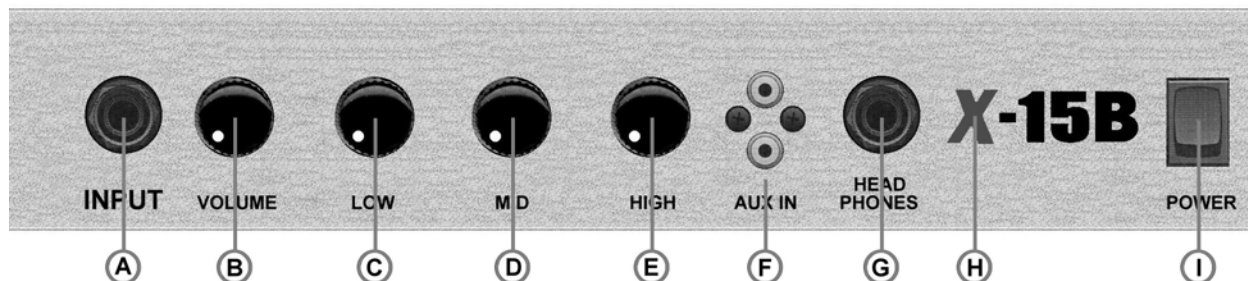


X-15B BASS AMPLIFIER

- AUX IN RCA input jacks for use with a portable CD or Tape player, drum machine, etc.
- Deltacomp™ adaptive compression virtually eliminates power-amp distortion for clear tone and punchy response.

X-15B Front Panel Functions



- A. INPUT** – Plug your bass guitar in here.
- B. VOLUME** – Adjusts the loudness of the amplifier.
- C. LOW** – Adjusts the low-frequency level as desired.
- D. MID** – Adjusts the middle-frequency level.
- E. HIGH** – Adjusts the high-frequency level.
- F. AUX IN** – RCA input jacks for use with a portable CD or Tape player, drum machine, etc. These input jacks are not affected by the amplifier's volume or tone controls; adjust the signal at the source.
- G. HEADPHONES** – Output jack for standard stereo or mono headphones. Using this jack automatically disconnects the speaker. This jack may also be used as an unbalanced line output by using either a stereo or mono ¼" phone plug connection.
- H. POWER INDICATOR** – Illuminates when the unit is receiving AC power.
- I. POWER SWITCH** – This switch turns the unit ON and OFF.

- Maintain at least 6 inches (15.24 cm) of unobstructed air space behind the unit to allow for proper ventilation and cooling of the unit.
- This product should be located away from heat sources such as radiators, heat registers, or other products that produce heat.
- This product may be equipped with a polarized plug (one blade wider than the other.) This is a safety feature. If you are unable to insert the plug into the outlet, contact an electrician to replace your obsolete outlet. Do not defeat the safety purpose of this plug.
- Protect the power supply cord from being pinched or abraded.
- This product should only be used with a cart or stand that is recommended by the manufacturer.
